Spiritual Care “Research-Informed” Syllabus for CPE Resident Chaplains

Objectives of Research Related Curriculum Events:

- To engage CPE Residents to develop research literacy as a “habit” for and dimension of their ministry practice.
- To clarify, broaden, and deepen CPE residents’ awareness of chaplaincy-related research and worthy research articles that contribute to a research-informed approach to their provision of spiritual and religious care.
- To develop the capacities of CPE residents to become critical readers of research related to spiritual care and to develop their confidence as informed research consumers.
- To foster interest and curiosity in CPE residents about their own and others’ provision of spiritual and religious care that give rise to research inquiry and thinking.

Research-related curricular “events” will be integrated throughout the CPE residency year. The initial weeks of orientation to the hospital and related clinical sites will include basic, orienting seminars such as those that familiarize CPE Residents with Medical Terminology, Behavior-Based Expectations (BBEs) that ensure patient safety, and the various on-line and in-person resources to support and to guide the provision of spiritual and religious care. These orienting seminars are understood to provide the foundation of information and resources on which the more specific research-related seminars will draw.

In the inaugural weeks of each CPE resident year, initial Seminars will focus attention on the inhibiting and promoting influences related to Research-Informed Spiritual Care, learning the basic concepts and frames of reference about research, and accessing the basic, available resources needed to develop capacities for one’s own research-informed ministry practice. Seminar foci will then shift to reviews of categories of research articles and the habits of thought needed to critically review and discuss articles for their relevance to chaplaincy practice. The preparatory readings for each of these seminars are identified with the expectation that students will read and summarize in writing their review of the articles prior to each seminar. Standard “Article Summary Outlines” will be utilized for this purpose. Residents are encouraged to review their seminar schedules well enough in advance to prepare their work in advance of each research seminar.

As noted before, CPE Residents are expected to participate in Mission and Spiritual Care Journal Club meetings, normally held on the second and fourth Wednesdays at noon. Location may vary, so check departmental announcements. Articles to be read for the Journal Club meetings will also be summarized utilizing the “Article Summary Outline” form in advance of the meetings.

The research seminars, identified readings and summaries, and Journal Club participation all provide opportunities for chaplain students to develop foundational knowledge and skills to be applied as part of their “routine” provision of spiritual and religious care in the clinical areas in which they minister. All CPE student chaplains are expected to become research-informed and literate in regard to the needs, characteristics of, and best care practices for the particular patient population she or he is serving. Conversation and consultation with other interdisciplinary care team staff in reference to care plans for particular patients is considered normal pastoral care practice.
